ORDER

As per the University Order read (1) above, University had issued Guidelines for “Double the Duration” in Academic Stream. That means a student who got registered in a course under KUHS shall have to pass the course within the time period twice that of the course period.

As per University Orders 2,3 &4 above , students admitted between 2010 and 2012 had granted additional mercy chances till 31.12.2024. Additionally, this benefit has been extended to all students up to 2016 admissions who have not cleared the course even after completing double the duration of the course period, with the discretionary authority as Controller of Examinations upto 31.12.2024.

As per University Order read (5) above, additional mercy chance benefits have been extended till

31.12.2025 for all students upto 2016 admissions , except those students admitted to courses in which either the time limit or the number of Mercy chances that can be permitted, are specified in the respective Course Regulations of KUHS or Statutory Council.

Vide read 6th above, the committee appointed by the Academic Council to analyse the details of students from all courses who are registered under the University but have not completed their course within the stipulated course period put forth the following recommendations.

- i. In courses, where only the University decisions regarding double the duration permitted to complete the courses are in force, the last date for completion of the course may be extended to 31.12.2026 as a one-time measure. (Double duration plus 2 years)
 - a. Those students will be permitted to attend the University Examination which commence on or before 31.12.2026.

The 87th Governing Council vide decision read (7) above has approved the above recommendation of the committee.

In the circumstances, sanction is hereby accorded that in the courses for which only the University decisions regarding the period of double the time allowed for completion of the courses are in force, the last date for completion of the course shall be extended as a one-time measure up to 31.12.2026 for all students upto 2017 admissions, and these students shall be permitted to appear in the University Examination commencing on or before 31.12.2026.

The other terms and conditions prescribed in the previous University Orders read here shall remain the same, wherever applicable.
