ORDER

As per the regulation, curriculum and syllabus of Msc Audiology, Msc Speech Language Pathology and Bsc Nursing Semester courses, the supplementary examinations can be conducted only along with regular examination of consecutive batch. In order to avoid course lag in Msc Audiology, Msc Speech Language Pathology and based on several requests from various students union and students of Bsc Nursing semester courses, the 42nd meeting of the Board of Examinations, vide read as 1st above, decided to conduct special examination for these courses and further decided to replace the terminology "Special Supplementary Examination" with "Special Examination" in future examination notifications.

2. Subsequently, practical difficulties were reported regarding the identification of candidates as regular or supplementary under the revised terminology, particularly in the preparation of mark lists. The matter was placed before the 41st meeting of the Academic Council held on 23.12.2025 for consideration. The Academic Council considered the matter and vide read as 2nd above resolved to ratify the decision no's 42.07 & 42.26 of the 42nd meeting of the Board of Examinations with the modification that the terminology 'special' shall not be added to the examinations. It was further resolved that all Regular and Supplementary Examinations are to be conducted as per the Academic and Examination calendar. There shall be no special examinations, and this shall be applicable for all courses.





3.The 87th meeting of the Governing Council held on 30.12.2025 vide read as 3rd above resolved to approve the recommendations of the 41st Meeting of the Academic Council held on 23.12.2025.

4.Sanction is, therefore, accorded to implement the following decisions vide read as 4th above for all courses:

- The terminology "Special" shall not be added to the Examinations.
- Regular and Supplementary Examinations are to be conducted as per Academic and Examination calendar.
- There shall be no special examinations.
- This shall be applicable for all courses
