ORDER

The fee for examinations and other services rendered by examination Branch was prescribed vide paper read as 1st above. At present, the University is levying a fine of Rs. 5,795/- for the late submission of a Thesis. However, the said order does not specify any provision regarding the levy of a superfine for delayed registrations or submissions of the Thesis.

2. It has been observed that several students continue to submit requests for Thesis submission even after the prescribed fine period, thereby causing considerable administrative inconvenience in the timely processing of such delayed submissions. Considering the multiple requests received for late thesis registration and submission in respect of the Medical P.G. Degree/Diploma Regular and Supplementary Examinations (2022 Admission), October 2025 and the Medical Super Speciality Degree Regular and Supplementary Examinations (2022 Admission), December 2025, the Hon'ble Vice Chancellor has accorded sanction for publishing an extended Thesis Notification with a registration fee of Rs.3480/- and a super fine of Rs. 11,590/- for the said examinations.

3. The 42nd meeting of the Board of Examinations vide paper read as 2nd above reviewed the matter in detail and recommended the following:

1. Ratified the action of the Hon'ble Vice Chancellor to publish extended Thesis Notification which include Rs.3480/- registration fee and a Super fine of Rs. 11,590/- with regard to Medical PG Degree/Diploma Regular & Supplementary (2022 admission) October 2025 and Medical Super Specialty Degree Regular & Supplementary (2022 admission) December 2025.
2. To impose a Super fine of Rs. 11,590/- in addition to the thesis registration fee when the

Thesis registration is extended beyond the fine date for all upcoming Post Graduate

Examinations under all streams, wherever thesis submission is mandatory.

3. This will come into force for all thesis Notifications published from the date of issuance of the implementation order.
4. The decision shall be referred to the Finance Committee.

4. In light of the above, the Hon'ble Vice Chancellor has accorded sanction to implement the above decisions of the Board of Examinations with respect to imposing Super fine of Rs. 11,590/- in addition to the thesis registration fee when the thesis registration is extended beyond the fine date, wherever thesis submission is mandatory. This shall take effect for all thesis Notifications of upcoming Post Graduate Courses published from the date of issuance of the implementation order, subject to ratification of the Governing Council and Finance Committee.

5. Orders are issued accordingly.
