KUHS – Exam General (A) – Ceasing the conduct of Final Professional BHMS Examinations of 2015 Scheme in a phased manner - Decision No. 42.21 of the 42nd Board of Examinations - Implemented – Orders issued.

ORDER

As per the KUHS Academic Regulations 2016 (applicable from 2015 Admission onwards) for BHMS courses; "Clause 1.13 – Duration permitted for completion of the course" stipulates that - "The total duration of the course is four and half years + one-year internship. Every candidate for admission to the B.H.M.S. examinations shall undergo a course of certified study extending over four and a half academic years from the date of commencement of his study as per syllabus and curriculum prescribed for the course in Homoeopathic Medical College affiliated to the University. Every candidate shall complete the course including the passing of the examination in all subjects and complete the compulsory internship training within a period of eleven years (including internship) from the date of admission in first B.H.M.S Degree Course in the College concerned, failing which his name shall be removed from the rolls of the college".

2. The classes for 2015 B.H.M.S. admission batch was commenced on 11.11.2015 and as per the said regulations, students shall complete the course of study by 10.11.2026. Only students who pass the Final Professional Examinations in July 2025 will be able to complete the one-year internship within the prescribed period of 11 years. Based on these facts and in accordance with the recommendation of the Dean-Faculty of Homoeopathy, it was decided to conduct the Final Professional B.H.M.S. Examinations July 2025 as the final attempt for 2015 Admission BHMS students to pass their Final Professional BHMS examinations and to cease the conduct of Final Professional BHMS Examinations for 2015 admission afterwards subject to ratification of the Board of Examinations.

3. In view of the above, the 42nd meeting of the Board of Examinations vide paper read as 1st above considered the matter and ratified the above decision and further resolved to recommend the following:

1. Decided to terminate the conduct of the 2015 scheme Final Professional BHMS Degree
