In exercise of the powers conferred by Chapter XXXVI of the First Statutes 2013 of the Kerala University of Health Sciences, the 17th Academic Council meeting held on 3-11-2017 vide decision No. 17.32 has made the modifications in the eligibility criteria for admission to undergraduate courses conducted by Kerala University of Health Sciences. These modifications has been approved by 42nd Governing Council meeting held on 20-11-2017 and the Senate at its 3rd meeting held on 24-3-2018.

It is hereby notified that the following modification to the existing regulations, regarding the eligibility criteria for admission to undergraduate courses conducted by Kerala University of Health Sciences, published in the Kerala Gazette Extraordinary No. 1447 dated 13th July, 2017 vide Notification No. 2891/AC1/GEN A2/KUHS/2017 dated 12th May, 2017.

1. *Short title and commencement.*—(i) These regulations may be called the Revised Academic (1st Amendment) Regulations of all undergraduate courses 2018.

(ii) They shall be come into force on the date of their publication in the official Gazette.

2. In the Academic Regulations of all courses applicable from 2016 admission onwards the following modification shall be as indicated therein.

3. In the existing Regulations under heading "General Regulations" of all undergraduate courses sub heading clause 1.1—Eligibility for admission—"the Academic eligibility for admission to all undergraduate courses" are modified as follows:—

1. Separate minimum pass mark for Physics, Chemistry and Biology.
2. 50% aggregate for Physics, Chemistry and Biology and/or English wherever applicable as per the respective course regulations.
3. 50% exclusively for Biology/Biotechnology/Mathematics wherever applicable as per respective course regulations.

In exercise of the powers conferred by Chapter XXXVI of the First Statutes 2013 of the Kerala University of Health Sciences, the 18th Academic Council meeting held on 1-3-2018 vide decision No.18.09 has made the modifications in the Regulations of the BHMS course. These modifications has been approved by 44th Governing Council meeting held on 9-3-2018 and the Senate at its 3rd meeting held on 24-3-2018.

It is hereby notified that the following modification to the existing regulations of BHMS course, published in the Kerala Gazette Extraordinary No. 1447 dated 13th July, 2017 vide Notification No. 2891/AC1/GEN A2/KUHS/2017 dated 12th May, 2017.

1. *Short title and commencement.*—(i) These regulations may be called the Revised BHMS Course (1st Amendment) Regulations 2018.

(ii) They shall be come into force on the date of their publication in the official Gazette.

2. In the BHMS Course Regulations applicable from 2016 admission onwards, the following modification shall be as indicated therein.

3. Page No. 93, Clause 1.24 of the Existing Regulations under heading "General Regulations", sub heading "Partial Appearance in Examinations" states that "Partial appearance is permitted in all the University Examinations, provided the candidate satisfy 80% attendance in all subjects of the respective examination, including the subjects (theory and practical/clinical separately) in which the candidate is not appearing or ineligible to appear. (Minimum of 70% attendance is required in theory and practical/clinical separately in the non-exam going subjects). Such candidates shall not be eligible for the award of rank".

Modified as follows:—

"Partial appearance is permitted in all the University Examinations, provided the candidate satisfy 80% attendance in all subjects of the respective examination, including the subjects (theory and practical/clinical separately) in which the candidate is not appearing or ineligible to appear. Such candidates shall not be eligible for the award of rank".

These modifications has been approved by 44th Governing Council meeting held on 9-3-2018 and the Senate at its 3rd meeting held on 24-3-2018.

It is hereby notified that the following modification to the existing regulations of BHMS course, published in the Kerala Gazette Extraordinary No. 1447 dated 13th July, 2017 vide Notification No. 2891/AC1/GEN A2/KUHS/2017 dated 12th May, 2017.

1. *Short title and commencement.*—(i) These regulations may be called the Revised BDS Course (1st Amendment) Regulations 2018.

(ii) They shall be come into force on the date of their publication in the official Gazette.

2. In the BDS Course Regulations applicable from 2016 admission onwards, the following modification shall be as indicated therein.

3. Page No. 114, clause 1.9 (a) of the existing Regulations under heading “General Regulations”, sub heading “Condonation of shortage of Attendance” state that “for BDS Courses, condonation of shortage of attendance on genuine ground for subject/subjects (in theory or practical or both) up to maximum of 10% can be granted (on formal request by the candidate) once during the entire course period. The Principal/Head of Institutions are empowered to granting condonation of shortage of attendance on recommendation by Head(s) of the Department under intimation to KUHS with the prescribed fee.”

Modified as follows:—

“for BDS Course, condonation of shortage of attendance on genuine ground for subject/subjects (in theory or practical or both) up to maximum of 5% can be granted (on formal request by the candidate) once during the entire course period. The Principal/Head of Institutions are empowered to grant condonation of shortage of attendance on recommendation by Head(s) of the Department under intimation to KUHS with the prescribed fee.”

In exercise of the powers conferred by Chapter XXXVI of the First Statutes 2013 of the Kerala University of Health Sciences, the 18th Academic Council meeting held on 1-3-2018 vide decision No. 18.09 has made the modifications/deletions in the Regulations of the Paramedical courses. These modifications/deletions has been approved by 44th Governing Council meeting held on 9-3-2018 and the Senate at its 3rd meeting held on 24-3-2018.

It is hereby notified that the following modification/deletions to the existing regulations of Paramedical Courses, published in the Kerala Gazette Extraordinary No. 1447 dated 13th July, 2017 vide Notification No. 2891/AC1/GEN A2/KUHS/2017 dated 12th May, 2017.

1. *Short title and commencement.*—(i) These regulations may be called the Revised Paramedical Courses (1st Amendment) Regulations 2018.

(ii) They shall be come into force on the date of their publication in the official Gazette.

2. In the Paramedical Courses Regulations applicable from 2016 admission onwards, the following modification/deletion shall be as indicated therein.

3. Page No. 264, clause 1.3 of the existing Regulations of Bachelor of Science in Medical Laboratory Technology—abbreviated as B.Sc. (MLT) under heading “General Regulations”, sub heading Number of seats in one unit of admission—states that—minimum thirty”

Modified as “Number of seats in one unit of admission—Maximum thirty”

4. Page No. 269, clause 1.18 (2nd point) of the existing Regulations of Bachelor of Science in Medical Laboratory Technology—abbreviated as B.Sc. (MLT) under heading “General Regulations”, sub heading “Criteria for Promotion to next year” states that “the candidate shall be eligible to write the third year examination only after clearing all the papers of the first year and second year examination”. *“Stands deleted”*.

5. Page No. 269, clause 1.18 (3rd point) of the Existing Regulations of Bachelor of Science in Medical Laboratory Technology—abbreviated as B.Sc. (MLT) under heading “General Regulations”, sub heading “Criteria for Promotion to next year” state that “the candidate shall be eligible to appear for final year examination only after passing the third year examinations”

Modified as follows:—

“the candidate shall be eligible to appear for final year examination only after passing the first, second and third year examinations”.

6. Page No. 269, clause 1.19 (1st point) of the Existing Regulations of Bachelor of Science in Medical Laboratory Technology—abbreviated as B.Sc. (MLT) under heading “General Regulations”, sub heading “Carry over benefit” states that “A candidate having 80% attendance in theory and practical in all the subjects and minimum required internal assessment marks are eligible for promotion to next higher class up to third year.

Modified as follows:—

“A candidate having 80% attendance in theory and practical in all the subjects and minimum required internal assessment marks are eligible for promotion to next higher class up to Final year”.

7. Page No. 374, clause 1.3 of the Existing Regulations of Master of Science in MLT under heading “General Regulations”, sub heading “Number of seats in one unit of admission states that “The minimum intake of students in one batch is six”

Modified as follows:—

“The maximum intake of students in one batch is six”.

8. Page No. 404, clause 1.13 In the Existing Regulations of Master of Audiology and Speech Language Pathology—Abbreviated as MASLP under heading “General Regulations”, sub heading “Duration permitted for completion of the course states that “Duration of the course is two years. The maximum permitted time period to complete the course is twice the duration of the Course (4 years)”

Modified as follows:—

“Duration of the course is two years. The duration permitted for completion of the course shall be 3 years.”
