**ORDER**

1. In compliance to the orders of the Hon'ble High Court of Kerala in WP (C) 29483/2023 and connected cases, the university had decided to modify the pass criteria of MD Homoeopathy part II examination in consonance with the council regulation, vide order read (1) above.
2. The Hon'ble Vice Chancellor has accorded permission to implement the modified pass criteria recommended by the Dean faculty of Homoeopathy for the declaration of result of MD (Hom.) Part II Examinations held in March 2024, and also applicable to 2020,2021,2022, & 2023 PG admissions as a new scheme (2020 Scheme) subject to ratification of Governing Council, through the Board of Studies / Academic Council and the results were published accordingly.
3. The said matter was placed as an agenda in the the Board of Studies of Homoeopathy PG, Faculty of Homoeopathy and the meeting of subsequent Academic Council for ratification.
4. Vide papers read (2), (3) & (4) above, the modified pass criteria implemented for MD Homoeopathy part II examinations was ratified and vide U.O read (5) above, the decisions of Board of studies Homoeopathy PG were implemented in general and orders issued subject to ratification of Governing Council.

5. Vide decision read (6) above, the 82<sup>nd</sup> Governing Council ratified the decisions of 38.09 of the Academic Council and implementation orders issued as per the U.O read (7) above.
