DISSERTATION NOTIFICATION

It is notified for the information of all the concerned that all candidates who wish to appear for the upcoming **Master of Public Health (MPH) Part II Supplementary Degree Examinations, March 2026 (2017 Scheme)** and not submitted the Dissertation, have to submit a soft copy of the dissertation through the Head of Department and the Head of the institution, by remitting the prescribed fee as per the schedule given below.

- Plagiarism certificate shall be attached as part of the Dissertation.
- The submission shall include mandatorily, an undertaking (by the candidate) indicating that the document has been prepared by the candidate and that the document is the original work of the person and is free from plagiarism.
- The submission shall include a certificate from the Guide / supervisor that the work is free from plagiarism.
- In case of quoting one's own work a declaration regarding self-plagiarism shall be submitted.
- If the researcher is quoting a work which has more than one author including the researcher, the declaration regarding self-plagiarism from the co-authors shall be submitted.
- As per KUHS Academic Integrity and Plagiarism Policy, the acceptable limit of Plagiarism is 10%. The submission of Dissertation shall include a certificate of approval from an approved plagiarism detection software approved by UGC, stating the percentage of similarities detected.
- Admissible level of similarities: 10%. Dissertation with Plagiarism percentage above 10% will be rejected.

Instructions to the Principal / Head of the Institution

Remittance of Examination Fee:
