- **The project report (Soft Copy Only) should be submitted to University before 5.00pm on 08.10.2025.**
- The details of the project report shall be submitted online to the University from 22.09.2025 to 30.09.2025 with a fee of **Rs.1740/-**.
- Late submission of details of project report shall be submitted **online** from 03.10.2025 to 06.10.2025 with a fine of **Rs. 5795/-**.

.The students who belong to the admission years 2013,2014, 2015 and 2016 shall submit a request through Principal for availing the Mercy chance. The principals concerned shall submit online mercy chance applications on or before 15.09.2025. The hard copies of the consolidated mercy chance report along with the request of candidates shall reach the University via post on or before 18.09.2025.

(*Mercy chance fee-Rs.2160/- per examinations *Fine for delay in receipt of the application- Rs.2000/- per examination)

- **Plagiarism certificate shall be attached as part of the project report.**

i.The submission shall include mandatorily, an undertaking (by the candidate) indicating that the document has been prepared by the candidate and that the document is the original work of the person and is free from plagiarism.

ii. The submission shall include a certificate from the Guide / supervisor that the work is free from plagiarism.

iii. In case of quoting one's own work a declaration regarding self-plagiarism shall be submitted.

iv. If the researcher is quoting a work which has more than one author including the researcher, the declaration regarding self-plagiarism from the co-authors shall be submitted.

v. The submission shall include a certificate of approval from an approved plagiarism detection software, stating the percentage of similarities detected. Plagiarism tools approved by University Grants Commission shall be used to detect

vi. Admissible level of similarities: 10% (Certificate models and details are given in the Kerala University of Health Sciences Academic Integrity and Plagiarism Policy which is available in the University website.).

The Principal / Head of the Institution should collect project report fee from all the candidates and remit the consolidated amount to the University Fund through Online payment mode only.
