## POINTS TO BE NOTED

- 1.Plagiarism certificate shall be attached as part of the Thesis.
- 2. As per KUHS Academic Integrity and Plagiarism Policy, the acceptable limit of Plagiarism is 10%. The submission of Thesis shall include a certificate of approval from an approved plagiarism detection software approved by UGC, stating the percentage of similarities detected. Thesis with Plagiarism percentage above 10% will be rejected.
- 3. Thesis submission should strictly follow the KUHS Academic Integrity and Plagiarism Policy.

- 4.All candidates appearing for the examination have to submit only Soft Copy ( both CD and also through email) of the Thesis to the University & the Hard Copies (4 Nos) of Thesis duly signed by the Professor in charge of the SFRA shall be submitted to the SFRA within the date stipulated in the above table. Hard copy of the thesis need not be sent to the University.
- 5. The candidates failing to submit the Thesis on the prescribed date will not be permitted to appear the Examination.
- 6. The Soft Copies of the Thesis shall submitted to the University, the content of each Thesis should be a single PDF file, size not exceeding 5 MB; the name of the file should be the student's KUHS Permanent Registration Number (ID).
- 7.The Professor in Charge shall collect the Soft Copies of the Thesis of the students and shall be sent to University to the Email ID "pgayurvedadissertations@kuhs.ac.in" through Email ID of the Institution.
- 8.The Soft Copy (both CD and in e-mail) should have all the signatures scanned in it (The soft copy of the Thesis should be verified by the HOD & Guide concerned and the HOD should sign on the outer space of the CD using CD Marker) and submitted to the University within the date stipulated in the above table.
- 9.Soft Copy of the Thesis shall be prepeared after all the authorities concerned have signed the document. The soft copies without the signatures of concerned authorities will be rejected. 10.Certificate including the details of the Name & Register Number of the students, Plagiarism percentage and the software used for detecting the plagiarism with the signature of the Principal shall be submitted to the University after completing the registration process with fine and without fine.
- 11.The printout of Registration and payment details, signed by all the concerned, as per the Proforma should be submitted to the University within the date stipulated in the above table.
- 12. The fee should be paid by online. The fee once paid will not be refunded or adjusted under any circumstances
- 13. Thesis will not be accepted after the stipulated date (given in the above table) on any grounds and if received after the last date, it will not be considered for evaluation.

## Important points to be observed in online payment

- 1. Payment shall be made by internet banking/credit card/UPI.
