Sub: Second Year M.Sc. Nursing Degree Supplementary Examination, April 2026– Submission of Dissertation - reg.

It is notified for the information of all concerned that the candidates appearing for the Second Year M.Sc. Nursing Degree Supplementary Examination, scheduled to be conducted tentatively in April 2026, shall submit the details of the completed and authenticated Dissertation to the University online and the soft copy of the original Dissertation (PDF format in CD), shall be forwarded to the Controller of Examinations by registered post through the Principal/ Head of the Institution, along with a fee of Rs.1740/- (Rupees One Thousand Seven Hundred and Forty only) per Dissertation, as per the schedule furnished below.

## Points to be noted:

- The submission shall include mandatorily, an undertaking indicating that the document has been prepared by the candidate and that the document is the original work of the person and is free from plagiarism. Plagiarism certificate shall be attached as part of the thesis.
- As per KUHS Academic Integrity and Plagiarism Policy, the acceptable limit of Plagiarism is 10%. The submission of dissertation shall include a certificate of approval from an approved plagiarism detection software approved by UGC, stating the percentage of similarities detected. Dissertation with Plagiarism percentage above 10% will be rejected.
- Dissertation submission should strictly follow the KUHS Academic Integrity and Plagiarism Policy and KUHS Post Graduate Thesis/Dissertation Regulations 2024.
- Soft Copy of the Dissertation shall be prepared after all the authorities concerned have signed the document. The soft copies without the signatures of concerned authorities will be rejected.
- Certificate including the details of the Name, Register Number & Speciality of the students, Plagiarism
  percentage and the software used for detecting the plagiarism with the signature of the Principal shall be
  submitted to the University after completing the registration process.

Those who have submitted dissertation for previous examinations need not submit the same.

Mode of payment – Online, only through the Principal or Head of the Institution, by using net banking facility or credit card.
