ORDER

As per the university order read as 1st above, the rate of remuneration for the evaluation of Viva voce and Dissertation has been fixed for PG courses. But on introduction of certain undergraduate courses like Bachelor of Occupational Therapy, Viva voce and Dissertation were incorporated in the fourth year as part of the Course Syllabus. Since these components were not previously included in any undergraduate courses, distinct evaluation rates has to be set for undergraduate programs.

- 2. Pursuant to the above, the Controller of Examinations has directed to fix the remuneration rates for the evaluation of viva voce and dissertation of undergraduate courses at the rate applicable for the evaluation of practical examinations involving only viva voce (in cases where there is no practical) or only practical (in cases where there is no viva voce) in accordance with the provisions outlined in U.O 37/2023/EXAM GENERAL/KUHS, subject to the ratification of the Board of Examinations.
- 3. The matter was considered at the 41st meeting of the Board of Examinations and the Board of Examinations has ratified the action of the Controller of Examinations and approved the rate of remuneration for Viva voce and Dissertation Evaluation for UG courses (in cases where there is no Practical Examination) shall be fixed at the same rate as currently specified for Viva voce Examinations without practical examinations as outlined in U.O No.37/2023/EXAM GENERAL/KUHS vide paper read as 2nd above.
- 4. Subsequently, the 83^{rd} meeting of the Governing Council vide paper read as 3^{rd} above has resolved to approve the above recommendations of the Board of Examinations.
