ORDER

Considering changes in the number of evaluations in MD/MS Post Graduate Course Regulations issued by National Medical Commission, requests were received from the faculties to increase the remuneration of evaluations of both Theory and Clinical/ Practical. The 38th meeting of the Board of Examinations held on 28/02/2024 discussed the matter and subsequently referred to a Sub Committee of the Board of Examinations for the modification of remuneration for examination related duties. The recommendations of the Sub Committee at its meeting held on 17/05/2024 were placed in the 39th meeting of the Board of Examinations held on 28.05.2024.

2. The 39th meeting of the Board of Examinations vide paper read as 2nd above approved the recommendations of the Sub Committee of the Board of Examinations with modifications as stated below and referred the matter to the Finance Committee with direction to effect and the modifications for the examinations notified from July 2024 onwards.

- 3. The 65th meeting of the Finance Committee held on 28.05.2024 vide paper read as 3rd above considered the matter and resolved to recommend the rates of remuneration proposed for revising the remuneration for examination related duties and for subsequent placement before the Governing Council for appropriate decision.
- 4. The 79th meeting of the Governing Council vide paper read as 4th above has considered the above recommendations and resolved to approve the proposal for minimum remuneration in respect of MD/MS/MDS/PG Diploma/Super Speciality/M Phil examination related duties as recommended by the 39th meeting of the Board of Examinations without enhancing the rate per candidate.
- 5. In light of the above, the Hon'ble Vice Chancellor has accorded sanction to implement the decision of the Governing Council by fixing the minimum remuneration in respect of MD/MS/MDS/PG Diploma/Super Speciality/M Phil examination related duties without enhancing the rate per candidate. **The revised rates are effective for the Examinations notified from July 2024 onwards.**
- 6. The University Order read as 5th above stands modified to the above extent.
- 7. Orders are issued accordingly.
