Based on these guidelines, notifications were issued, for the year 2025, inviting applications from the eligible candidates to submit their applications within a period of one month, starting from **15.06.2025** to **15.07.2025** for the 'Award for the Publication of PG Thesis 2025' and from **01.07.2025** to **31.07.2025** for the 'KUHS Research Appreciation Award 2025' vide read (2) & (3) above.

2. Due to certain technical difficulties and various requests from the students to extend the last date for the submission of the applications for both the awards, the last date to submit the application for 'Award for the Publication of PG Thesis 2025', was extended beyond one month, till **30.07.2025** and the last date for the submission of the applications for the 'KUHS Research Appreciation Award 2025', till **14.08.2025**, vide paper read (4) & (5) above, as per the order of the





Vice Chancellor, subject to ratification of the Academic Council.

3.The Academic Council, vide decision read (6) above, has ratified the above action of the University in extending the date to submit applications for 'Award for the Publication of PG Thesis 2025' and 'KUHS Research Appreciation Awards 2025'. The Governing Council, vide decision read (7) above, has approved the recommendations of the Academic Council.

4. Sanction has been accorded by the Vice Chancellor to implement the decision.
