A. SIGNIFICANT ACCOUNTING POLICIES

- 1. Financial Statements are prepared on historical cost convention and on accrual basis unless otherwise stated.
- 2. The Grant-in-Aid received for Non plan expenditure is shown as income in the Income and Expenditure Account and Excess of Income over Expenditure for the year is added to Corpus/Capital Fund.
- 3. Fixed Assets are stated at cost of acquisition inclusive of all direct costs. Reduction/Deletion of asset value is due to changes in settlement of final bill of contractors.
- 4. Depreciation on Fixed Assets is provided at the rate specified u/s 32 of the Income Tax Act 1961.
- 5. Interest on Savings Bank Account is accounted on receipt basis and interest on fixed deposit is accounted on accrual basis from the year 2015-
- 6. Income from Fee is accounted on cash basis except the following
 - i. Application, registration and inspection fee for new college
 - ii. Application, registration and inspection fee for new course
 - iii. Application, registration and inspection fee for enhancement of seats
 - iv. Continuation of provisional affiliation fee
 - v. Annual Administration fee

B. NOTES TO ACCOUNTS

1. During the year the University has maintained the following bank accounts with State Bank of India.

- 2. The Current Assets, Loans and advances have the value at which they are stated in the Balance Sheet, if realised in the ordinary course.
- 3. Advances are given to the Examination Finance Wing for incurring expenses in connection with conducting examinations. Expenses incurred from the said advances are exhibited in a separate schedule 15 and the balance of ₹.1,80,44,421 remaining as on 31.03.2016 is shown under Current Assets.

- 4. Reconciliation between Fixed Asset Register and Fixed Asset schedule is yet to be completed.
- 5. KVAT liability for the month of January to March 2016 is to be revised.
- 6. Work contract tax for the month of March was paid on 15.4.2016 except work contract of HLL of ₹79,35,507.
- 7. KCWWF recovery of ₹.28,33,304 of HLL is yet to be paid.
- 8. Forest Development Tax is collected at 0.72% (₹.46) instead of 5% on sale of woods. The collected amount is not remitted to the department.
- 9. Application, Registration and Inspection fees are bifurcated into that relating to the year 2015-16 and for 2016-17. Advance fee totalling to ₹.95,00,000 is accounted separately under Current Liabilities and Provisions. Due to the recognition of such advance income, a disproportionate fall in such income is depicted compared to previous year 2014-15. Application, Registration and inspection fees for new course shows a declining trend during the year. It is due to decrease in the number of applications received during the year.
- 10. Continuation of provisional affiliation fee of ₹ 2,78,90,000 for the year 2016-17 is separately accounted as Advance fees received. Due to recognition of such advance income, such income shows a disproportionate fall compared to previous year 2014-15.
- 11. As against the establishment expenditure of ₹6,40,68,311 and administration and general expenditure of ₹4,06,92,353 for the year 2015-16, the non plan grant received from Government of Kerala was ₹1,00,00,000 only (One Crore Rupees), resulting in a shortage of non plan fund to the extend of ₹9,47,60,664. This shortage was met from the University's own fund.
- 12. For the year 2015-16 the fee for enhancement of PG seats in Medical and Dental streams, based on the number of seats was withdrawn, retaining the onetime fee collectable at the time of granting provisional affiliation for that course . This has resulted in a shortfall of ₹ 88,87,500/compared to previous year 2014-15.
- 13. The hike in examination expenses during the current year compared to previous year is due to increase of remuneration as well as regrouping of expenditure heads.
- 14. Provision of arrear salary of ₹ 38, 00,000 is made during the year as per the management note.
- 15. Provision for student support scheme of ₹ 1,13,40,000 is made during the year as per order no.105/ Dean SA/ KUHS/2016.
- 16. The cost of staff quarters buildings constructed by Kerala PWD is not included under Fixed Assets since the cost was borne by them.
- 17. The figures of Balance Sheet, Income and Expenditure account and Receipts and payments account have been rounded off to nearest rupee.
- 18. Previous year figures have been regrouped, wherever necessary to match with current year's presentation.
